

ANNEX II

REQUIRED DOCUMENTS TO VALIDATE THE STATUS OF REFUGEES, LOW-INCOME ASYLUM SEEKERS AND HUMANITARIAN VISA HOLDERS

I – People whose refugee status has been recognized by the National Committee for Refugees (CONARE) or a competent federal agency:

Proof of refugee status recognized by CONARE or a competent federal agency.

II – People who have claimed asylum with CONARE or a competent federal agency, whose per capita family income (gross) is equal to or less than one and a half minimum wage:

Confirmation of application for asylum and Self-declaration of income validated by a committee appointed by the Prorectorate for Affirmative Action and Equity (Proafe) (procedure to be done during the registration period);

III – People holding a humanitarian visa:

Permanent or temporary humanitarian visa issued by the Federal Police.

IV – People entering the country due to family reunion in accordance with the conditions in items I and III:

Family reunion visa or confirmation of request for extending the effects of refugee status to family members, in accordance with the procedures that regulate Law no. 9474/07.

REQUIRED DOCUMENTS FOR REGISTRATION AT UFSC

1. Identification documents (ID, passport, home country's card and CPF) which were presented by the applicant for the UFSC Admission Selection Process for Refugees 2024;
2. Document proving equivalence to the completion of secondary education abroad, issued by the State Council of Education, or secondary school diploma and transcript or equivalent, if it was completed in Brazil. Higher education degree holders must present the degree certificate;
3. Self-declaration of refugee, low-income asylum seeker or humanitarian visa holder, and self-declaration of income (for people who have claimed asylum and whose per capita family income – gross – is equal to or less than one and a half minimum wage), validated by the PROAFE committee. 4. Certificate of vaccination against rubella (for female applicants up to 40 years old – Law no. 10196/1996/SC);
5. Proof of vaccination against COVID-19 (the vaccination certificate issued by the *ConecteSUS* platform or a proof/booklet/card/passport of vaccination printed on letterhead, issued at the time of vaccination by a Brazilian or foreign government institution, with legible data and the correct identification of the holder, will be accepted as proof – applicants with a contraindication to getting the COVID-19 vaccine must present a medical certificate justifying the contraindication, with precise medical information in this regard (Normative Ordinance No. 429/2022/GR, of 9 March 2022, altered by Normative Ordinance No. 462/2022/GR, of 22 December 2022).

Below is information from the UFSC Commission for Epidemiological Monitoring on the Ministry of Health's recent recommendations regarding the COVID-19 vaccination strategy.

- the two-dose vaccination schedule is in force for healthy young people and adults.
- people who have had more doses according to the vaccination schedule previously recommended should follow the recommendations and updates regarding the particular target groups and age groups.
- the vaccination schedules for healthy young people and adults with incomplete schedules (unvaccinated or with only one dose) will consist of two doses:
 - a) two monovalent doses (D1+D2)
 - b) one monovalent and one bivalent dose (D1+BIV)
 - c) two bivalent doses (BIV+BIV).
